IMMIGRATION ACT, 2002 (ACT NO. 13 OF 2002)**[Section 4(2)(a)(v), Regulation 4]****NOMINATIONS OF CANDIDATES TO SERVE AS MEMBERS OF THE
IMMIGRATION BOARD**

Section 4(2)(a)(v) of the Immigration Act, 2002 (Act No. 13 of 2002) (the "Act") empowers the Minister of Home Affairs to appoint **up to five (5) individuals** on the basis of their knowledge, experience and involvement pertaining law, control, adjudication or enforcement.

The Minister of Home Affairs, Dr L.A. Schreiber, MP, hereby invites members of the public or interested parties to nominate individual persons to serve on the Immigration Advisory Board for a period of four (4) years.

The nominations must be accompanied by:

- Confirmation from the nominated person that he or she accepts such nomination; and
- A comprehensive Curriculum Vitae demonstrating the nominated person's knowledge, experience and involvement pertaining to immigration law, control, adjudication or enforcement.

The closing date for nominations is **7 September 2024** and should be directed to
