I, R.B Makamu, Member of the Executive Council responsible for Co-Operative Governance, Human Settlements & Traditional Affairs in Limpopo Province hereby amend Provincial Extraordinary Gazette number 3411 notice 308 of 2023 dated 30 June 2023, by powers vested in me in terms of section 23(2) of the Local Government: Municipal Demarcation Act, 1998 (Act 27 of 1998) as follows:

The Electoral Commission has in terms of section 23(3) of the Local Government: Municipal Demarcation Act, 1998 (Act 27 of 1998) recorded its view on the boundary re-determination published in the Limpopo Extraordinary Gazette number 3516 notice 408 of 2024 dated 26 April 2024.

The below mentioned boundary re-determination in schedule 1 will come into effect from the date of the next local government elections.

DEM7501	The Municipal Demarcation Board has re-determined the municipal boundaries of Greater Letaba Local Municipality (LIM332) and Greater Giyani Local Municipality (LIM331) by excluding Skhiming and Bochabelo villages from the municipal area of Greater Giyani Local Municipality (LIM331), and by including them into the municipal area of Greater Letaba Local Municipality (LIM332).
DEM7511	The Municipal Demarcation Board has re-determined the municipal boundaries of Modimolle-Mookgophong Local Municipality (LIM368) and Bela Bela Local Municipality (LIM366) by excluding portion 213 of farm VERLOREN 787 KR from the municipal area of Bela-Bela Local Municipality (LIM366), and by including it into the municipal area of Modimolle-Mookgophong Local Municipality (LIM368).
