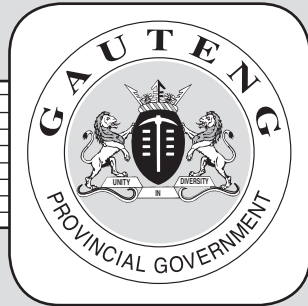

1. Nomusa Trading Enterprise (Pty) Ltd, Trading as Red Moon Bistro and Pub, situated at 55 Lanham Street, Bronkhorspruit, in the District of Tshwane.
