PROPOSED EXEMPTION PERMIT FEES FOR 2019/2020

It is one of the basic functions of the Abnormal Loads Technical Committee to recommend the fees relating to exemption permits. For obvious considerations of credibility and efficiency fees should be uniformly calculated and applied by all provinces. The new fees will be effective from a date to be determined by notice in the gazette.

The proposed fees are set to optimise the income derived by the provincial governments based on actual scientifically determined costs and indexed to the Producer Price Index (PPI)
